

In brief: The club is \$17,691 in profit, green fees are up 26%, honour box up 25% Lorraine voiced that she would continue as treasurer for one more year and to strive to identify numbers of visitors who come to play our course.



LGC Treasurer's report 2022

For the year ended 30 September 2022 the Lancelin Golf Club made a profit of \$17,691.

Income to note included:

- Green fees up 2.6% from last year and Honour Box takings up 25%
- Memberships up 11% from the prior year
- Miscellaneous revenue was sales of club shirts of \$3,221

Expenses to note included:

- Miscellaneous expenses of \$8,422 include \$2,342 Golf Australia and Central West Coast membership fees, \$4,884 purchase of club apparel and \$1,196 of other miscellaneous expenditure.
- \$840 spent on new score cards

\$8,995 was spent on asset purchases – New Sprayline and \$2,200 was spent on turf.

As at 30 September the LGC had \$50,248 in the bank in 4 different accounts, including some \$19,227 in term deposits.
