- 3. MINUTES FROM PREVIOUS MEETING: Proposed: June Gooch 2nd Kevin Cain Carried

4. BUSINESS ARISING FROM PREVIOUS MEETING

4.1. Upgrade of reticulation controller 17/1/21 – update; TII were contacted to upgrade the control box. A pressure transducer is required which has been agreed by committee at \$880 +GST \$88 from Bradley Pope. Installation has been hampered by COVID restrictions and will be completed at our behest.

5. REPORTS

- 5.1. The Captain deferred his report until next meeting.




Figure 1 Club expenditure

- 5.2. The Treasurer delivered her detailed report eloquently and confirmed that the club continues to thrive and remains self-funding; Figure 1 is a pie chart at the bottom of these minutes which show the breakdown of expenditure; thank you Lorraine.
- 5.3. However, we must all be vigilant regarding the threat from the shire which despite their assurances still hangs over us like the Sword of Damocles; the shire is still exploring ways of closing us down.

7. GENERAL BUSINESS

- 7.1. Membership stands at 47 renewed; there was some doubt whether LGC is liable to pay levies for "Life Members" to LCSC; the question was elevated to LCSC for clarification; this is the response.

- 7.2. GolfWA Membership Affiliation Fees are NOT transferable; they are unique to the parent club.
- 7.3. Rotary volunteers kind offer of work will be confined to Saturday 27th March, Kate Parker and between 12 and 16 helpers will arrive at the club at 0800 to work until 4:40pm. Kate has been told that the 40+ control boxes on the course are the priority to be cleaned of sand and rubbish. I have offered her and the team lunch in the form of rolls/sandwiches; there are two vegetarians on the team. They will have with them their own PR guy who will be taking photographs, our own Louise has been asked to do the same, there is no objection to the use of a drone. Kate's team have been supplied PPE by Bunnings in the form of gloves. I suggest that we open the bar at 4:30pm and all join in for drinks/sundowners. Volunteer Ladies to provide lunch; Lorraine please come up with a figure which we can have committee agree to fund food.

- 7.17. Act-Belong-Commit Partnering: Mike described how other active entities have partnered with ABC and wishes the club to proceed with the partnering process.
- 7.18. Sponsorship package draft (comments): No additional comments or additions offered up for the package.
